Dockendorf and his guests were evacuated without injury as the fire spread. Over the years the many additions to the building included false ceilings and ideal spaces for the fire to spread undetected. Soon the entire roof was up in flames and, in spite of the Pequot Lakes Fire Department's valiant efforts, the blaze destroyed the entire facility.

> of the One treasures lost in the fire was the 'Salad Boat". Used as the base for the salad bar in the dining room, it was made of cedar in 1942 by the Larson Boatworks Little Falls, MN. The motor was built in 1918 by Ole Evinrude and had been used by "Captain Billy" Fawcett in the 1920s.

Slot Machines Were a Fixture

Honoring his 1946 campaign promise, Luther Youngdahl, the governor Minnesota, embarked on a wholesale crusade to rid the state of gambling in general, and slot machines in particular. The April 24, 1947, passage Youngdahl's "anti-slot machine" bill sounded the death knell for slot machines in Minnesota. One of the larger Youngdahl targets was Breezy Point Lodge.

Long before the first golfers of the day have even thought about getting out of bed, Jerry Sundstrom and Al Schmidt will be found somewhere on the golf courses of Breezy Point Resort. Starting at 4 AM, they're behind the scenes, prepping the courses for another day of great golf.

Jerry, a 1965 graduate of Pequot High School, became a Resort employee on the golf course in June of 1967 when the front-nine of the Traditional Golf Course was the Resort's only course. The back nine had been out of use since the 1966 bankruptcy and had been reclaimed Mother Nature.

learning the basics of golf course maintenance, Jerry was instrumental in the rehabilitation of the back-nine in 1968.

Pequot Lakes School, returned to the area after serving in the U.S. Air Force and, with the encouragement of Jerry, became a Resort employee in 1971.

Jerry and Al are the proverbial "jacks-of-alltrades" when it comes to the operations of the golf courses. In addition to the obvious grass cutting duties on the fairways and greens, they have the responsibility for maintaining the irrigation systems, plantings, and hazards.

Without the benefit of a map of the irrigation lines, they know every inch of the lines on both courses.

Excavating to repair leaks is a common activity, particularly on the front-nine of the Course Traditional where the lines are the steel pipe installed in the 1920s.

Fact or Fiction?

(Editor's note: Frequently we receive stories about the history of Breezy Point Resort that would be of interest to our readers. The accuracy of these stories and the memories of the tellers are not always clear and need a bit of research to uncover the facts. See the next issue for the results of our research.)

Tommy Carroll, a convicted felon and criminal associate of gangsters John Dillinger and Babyface Nelson, arrived in Brainerd in October of 1933. Along with Babyface Nelson and three others, they stayed at the Sebago Resort on Round Lake. vacation.

Their mission was the robbery of the First National Bank on the corner of South Sixth and Front in Brainerd. Having cased the bank learning names of the employees, they broke into the bank on the morning of October 23rd and waited for the automatic lock on the vault to open at 8:45 AM. Brandishing machine guns, they relieved the bank of \$32,000 and made their getaway.


